USTA's "Get Safe Play Approved" Promotion Terms

The United States Tennis Association Incorporated ("USTA" or "Sponsor") 2024 USTA Safe Play Approved Promotion (hereinafter, the "Promotion") is offered only to legal residents of the 50 United States (including the District of Columbia and other locales under United States jurisdiction, including Puerto Rico, Guam, American Samoa, American Virgin Islands, and other protected territories), who are 18 years of age or older at time of entry and who has met the criteria below.

- 2. You will be asked to sign into your USTA account.
 - a. Input your credentials and click sign in. If you've forgotten your USTA account password, click "Forgot Password."
 - b. If you do not already have a USTA account, you can create a free account.
- 3. Complete the Personal Information section. Once completed, click "Next: Course & Policy".
- 4. Click "Launch Training" to continue the process.
 - Review and accept the SafeSport Terms and Conditions and the Safe Play Policy. Check the box to agree and click "Continue." The SafeSport Training will open in a new window. Complete the SafeSport Training as prompted.
 - b. Close the window and return to your USTA account. You can download your certificate by clicking "View Course History" under the step 2 circle, "Course & Policy" on the "Get Safe Play Approved" page.
- 5. Click "Next: Background Check."
- 6. Click "Launch Background Check." You will be directed to the National Center for Safety Initiatives (NCSI) website to complete the screening process.
- 7. Fill out the NCSI background check application. It may take NCSI 5-10 business days to complete your background check after you have submitted the form.

PLEASE NOTE: The Promotion Period ends on November 29, 2024 and the NCSI background check must be completed and approved by this date. Participants who do not receive their confirmation that the background check has been approved and receive confirmation of "Safe Play Approved" status from USTA before expiration of the Promotion Period will not qualify as an eligible Participant and will not be eligible to receive a Promotional Gift.

8. Upon completion of all steps, your Safe Play status can be confirmed as "Safe Play Approved" by going to the "Get Safe Play Approved" webpage and confirming that all three steps, represented in the circles at



the top of the page (Personal Information, Course & Policy and Background Check) appear is green when logged in to your USTA Account.

Promotional Gift Card Reward: The first one-thousand (1,000) Eligible Participants to complete each of the above Safe Play Approval requirements and confirm their Safe Play status as "Safe Play Approved" during the Promotion Period will receive a gift of one (1) digital gift card code for TennisExpress.com worth Seventy-Five Dollars (\$75.00) toward a purchase of goods from TennisExpress.com ("Promotional Gift"). Promotional Gifts will be awarded while supplies last (only the first 1000 eligible Participants will receive a Promotional Gift).
