# NTRP REVIEW COMMITTEE <u>DYNAMIC DISQUALIFICATION</u> GUIDELINE PROCEDURES (11)

This Committee has the responsibility for ensuring that proper procedures have been followed and due process granted.

### **Decisions by NTRP Review Committee must include:**

- 1. Findings of fact jurisdiction.
- 2. Decision based on findings of fact and the guidelines set forth below.
- 3. Findings of fact disqualifications.

#### **Jurisdiction**

Reviews to an NTRP disqualification are based on USTA League Regulation **2.04 League NTRP Disqualification and Review Procedures**. Following notification of a disqualification, if the team captain of the player disqualified wants to Review the disqualification, he/she must request, in writing, a <u>review</u> before the NTRP Review Committee of the nearest available jurisdiction. The request shall be delivered to the Chairman of the NTRP Review Committee within the deadline set by the administrator or the chairman of the Championship Committee.

#### **Disqualifications**

In the event of an NTRP disqualification under USTA League Regulation 2.04, the NTRP Review Committee shall:

- Ensure that proper procedures were followed by the section (see questions below)
- Review information submitted by the Reviewing party that had not previously been entered as computer data input or records that show incorrect data input.

### **Questions to be asked by the NTRP Review Committee include:**

- Was the NTRP Disqualification Report run in the manner prescribed in the USTA NTRP Computer Methodology Procedures?
- Was the player properly notified in accordance with USTA League Regulations?

## **Disqualification Criteria**

The section will run the NTRP Disqualification Report on an *as needed* basis. NTRP Disqualification will occur when an individual has reached the disqualification level three (3) times based on the USTA League match results appearing in the file and as determined in the USTA NTRP Computer Methodology Procedures.

#### Review guidelines

- 1. The NTRP Review Committee <u>shall</u> review any additional information presented by the Captain.
- 2. The Committee shall determine if the player record is accurate and complete.
- 3. The Committee <u>shall</u> determine if the information presented by the captain impacts the accuracy of the player records.
- 4. <u>If the NTRP Review Committee deems it necessary to hold a hearing, these hearings may be</u> conducted in person or by conference call with the involved parties.
- 5. The Committee shall reach its decision and notify the affected player(s) and captain(s) in writing of its decision.
